- Expansion of RAINS and GAINS models (EECCA countries should contribute information and nominate a contact person to IIASA, IIASA should try to provide travel funds and give feedback with the developed scenarios)
- Active participation in negotiations (EECCA countries)

Strengthening of the EMEP system

- Provision of emission data (EECCA countries)
- Practical, methodological support and capacity building in the establishment of new station(s) including assessment of resources needed to establish new monitoring stations) (pilot project implemented by 2-3 EECCA countries in collaboration with EMEP Steering Body and CCC and with donor support)
- Extend modeling domain (MSC-East and MSC-West)
